The Board of Directors bring to the attention of Members the importance of keeping within quota allocation if a year round fishery is to be achieved. Transgressions of quota observance will be severely dealt with. **Remember under the Landings Obligation's fish cannot be dumped, if you believe you are going to break quota allocation please move area to avoid the unwanted catches.**
